

IOWA GYM RATS: COVID-19 RESPONSE

(Updated 4/19/2021)

- **SPECTATORS, COACHES, STAFF, SCOREKEEPERS, PLAYERS AND OFFICIALS MUST WEAR A MASK. THIS IS MANDATORY.**
- **PLAYERS AND OFFICIALS ARE NOT REQUIRED TO WEAR A MASK WHEN PLAYING OR OFFICIATING**
- **WE ARE ASKING COACHES TO WEAR THEIR MASK TO COACH**
- **NO ONE WILL BE ALLOWED IN THE FACILITY IF THEY ARE NOT WEARING A MASK. BRING YOUR OWN AS WE WILL NOT GIVE MASKS OUT. YOU WILL BE ASKED TO LEAVE UNTIL YOU RETURN WITH ONE.**
- **TEMPERATURES WILL BE TAKEN AT THE DOOR. ANYONE WITH 100.4 TEMP WILL BE ASKED TO LEAVE.**
- **THERE ARE NO SPECTATOR RESTRICTIONS AT THIS TIME. YOU ARE ASKED TO SOCIAL DISTANCE TO THE BEST OF YOUR ABILITY.**
- **PLAYERS AND PARENTS/GUARDIANS NEED TO COME INTO THE FACILITY TOGETHER. DO NOT DROP YOUR CHILD OFF AND LEAVE TO PARK. PARK AND COME INSIDE THE FACILITY TOGETHER.**
- **ONCE YOUR TEAM'S GAME IS OVER PLEASE LEAVE THE SEATING AREA AND GO TO YOUR CAR, GET A BITE TO EAT OR FIND AN AREA INSIDE THE FACILITY WHERE YOU CAN SOCIAL DISTANCE.**
- **GAMES WILL START ON TIME, PLEASE DO NOT SHOW UP MORE THAN 20 MINUTES BEFORE GAME TIME.**
- **PLEASE DO YOUR BEST TO SOCIAL DISTANCE.**
- **If you are sick or someone in your circle of friends and family are - stay home.**
- **Individuals that are "at risk" need to stay home.**
- The concession area will be open – Please throw away your trash and do not congregate in the concessions area.
- No handshakes after games.
- Teams will not be allowed to share water bottles. All individuals will be instructed to bring their own.
- Sports balls will be wiped down before each game, at each timeout, at halftime and after each game.
- **WARM UP BASKETBALLS PROVIDED BY TEAM. HOME TEAM PROVIDES GAME BALL WHICH WILL BE SANITIZED BY THE OFFICIALS BEFORE AND THROUGHOUT THE GAME.**
- While supplies last we will keep hand sanitizer will at scorer's table. **Teams are asked to bring their own.**
- Hand sanitizer will be available throughout the facility.
- Please limit gathering inside the facility. Team meetings can take place outside as weather permits.
- There will be a dedicated staff member to monitor compliance throughout the facility.
- All staff members are screened with questions about travel, health, temperature and contact with anyone who has tested positive for COVID-19.
